

**COVENANTER SCOTTISH FESTIVAL
AND
HIGHLAND GAMES – 2020**

**Assumption of Risk and Waiver of Liability
Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have published various health and safety guidelines. The Octorara Covenanter Presbyterian Foundation (“OCPF”), organizer of the Covenanter Scottish Festival (the “Festival”), and Middle Octorara Presbyterian Church (“MOPC”), the owner of the property (collectively OCPF and MOPC are the “Hosts” of the event) have decreased the number of tickets available for the Festival and put in place various preventative measures to reduce the spread of COVID-19; however, the Hosts cannot guarantee that you or anybody attending the festival will not become infected with COVID-19. Further, attending the Festival could increase your risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I or my minor children may be exposed to or infected by COVID-19 by attending the Festival and that such exposure or infection may result in personal injury, illness, permanent disability, or death. I understand that the risk of me or my minor children becoming exposed to or infected by COVID-19 at the Festival may result from the actions, omissions, or negligence of myself, my children, and others, including, but not limited to, Festival employees, volunteers, and participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury of any kind that I or my minor children may experience or incur in connection with attending the Festival including, but not limited to, personal injury, illness, permanent disability, or death.

On my behalf, and on behalf of any and all of my minor children attending the Festival, I hereby release, covenant not to sue, discharge, and agree to indemnify, defend and hold harmless OCPF and MOPC, their employees, agents, representatives and volunteers, of and from any and all claims, including but not limited to all liabilities, actions, damages, costs, or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any and all claims based on the actions, omissions, or negligence of OCPF and MOPC, their employees, agents, representatives and volunteers, whether a COVID-19 infection occurs before, during, or after attendance or participation at the Festival.
